RECOMMENDATION

Chief Information Officer requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 190297B with Intuitive Performance Solutions, Inc., increasing the agreement by \$4,950 to a maximum of \$8,250, with no other changes to the agreement, to assist with ongoing support for the SAS Financial Management budget system.

EXECUTIVE SUMMARY

Intuitive Performance Solutions, Inc. (IPS) was selected by the County to assist Information Technology Services (ITS) with the initial SAS budget module implementation and subsequent upgrades. IPS is very familiar with the County's SAS environment and is less expensive than SAS consulting services. Agreement No. 190297B, which included ongoing consulting support for the SAS Financial Management support team, was approved by the Board of Supervisors on April 23, 2019. On August 20, 2019, the Board of Supervisors approved Agreement 200085B to upgrade our system from 5.5 to 5.6. This amendment is intended to allow IPS to assist with ongoing support in between SAS upgrades.

Since the approval of the support agreement there are additional support needs, such as system changes, application updates, and general assistance related to the County's SAS Financial Management system. The ITS division estimates 50 hours is a more accurate indicator of the support hours now required to ensure SAS budgeting module is working effectively in preparation for the FY20-21 budget cycle. ITS is seeking approval to amend Agreement No. 190297B with IPS to increase ongoing support hours for the SAS Financial Management (FM) system.

IPS is not a local vendor.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

On June 28, 2011, the Board approved the purchase of SAS Financial Management software to be used as the County's budget application. The application was upgraded to version 5.3 in FY 14-15 to maintain data input and reporting compatibility, fix identified software defects, apply security updates, and provide product enhancements. The application was upgraded to version 5.5 in FY 18-19. The 5.5 upgrade included enhancements for process management support, data validation, data entry, and reporting options. In October 2018, a bug related to running employee calculations from within the budget tool was discovered. It was later determined that SAS had changed a component of the software. An amendment to the 5.5 upgrade agreement included an additional 160 work hours to address the issue and extend the term of the agreement to provide additional time for IPS to implement the solution. Agreement 190297B, which included ongoing consulting support for the SAS Financial Management support team, was approved by the Board of Supervisors on April 23, 2019. On August 20, 2019, the Board of Supervisors approved Agreement 200085B. As of result of SAS changing its use of embedded Flash technology to HTML5 technology, consulting support from IPS was needed to upgrade our system from 5.5 to 5.6.

Since the approval of the support Agreement 190297B, there are additional support needs related to the County's SAS Financial Management system. The ITS division estimates 50 hours is a more accurate indicator of the support hours now required to ensure SAS budgeting module is working effectively in preparation for the FY20-21 budget cycle. This includes requests for system changes, application updates, and general support for the County's SAS FM support team. Amending the agreement will allow ITS to continue to utilize IPS' ongoing support to the County's SAS Financial Management budgeting application.
