SUBJECT: Contract Amendment with Howard Siegel for Housing Element Update

RECOMMENDATION

Director of Planning, Building & Environmental Services requests approval of an authorization for the Chairman to sign an agreement with Howard Siegel for a maximum of \$53,000 for the term September 24, 2013 through June 30, 2014, with a provision for automatic renewal, for project management services relating to the 2014-2022 housing element update.

EXECUTIVE SUMMARY

State law requires the County to update the housing chapter or "element" of its General Plan on a regular basis, and an update for the planning period 2014-2022 must be completed by January 2015. County staff is seeking assistance with project management of the update, and Howard Siegel is a local planner with extensive experience working on housing issues in the County, having worked on the last housing element update.

Where is it budgeted? The PBES budget unit, general plan subdivision includes funding for

maintenance of the County's general plan. Funding is derived from the general fund and from a 1.8% surcharge on applications processed by the

department.

Discretionary Justification: Retaining an experienced project manager will ensure the housing element is

updated in accordance with State law and well in advance of the

State's deadline.

Is the general fund affected? Yes

Future fiscal impact: The contract will renew automatically at the end of the fiscal year. While the

bulk of the work included in this contract will occur before June 30, 2014, it is likely that some tasks will extend until the deadline for housing element

adoption in January 2015.

Consequences if not approved: Staff will have to set aside other work to undertake the project management

tasks included in this contract.
