SUBJECT: Probation Office Closure

RECOMMENDATION

Chief Probation Officer requests authorization to close the Probation Department offices located on Walnut Street (Juvenile Division) and 3rd Street (Adult Division) on Monday, October 8, 2018, Columbus Day and a court holiday, between the hours of 8 am and 1 pm, in order to provide a half-day training to staff.

EXECUTIVE SUMMARY

The Chief Probation Officer requests approval for the Probation Department to close its offices on October 8, 2018, which is an observed Napa County Superior Court holiday, from 8:00 am to 1:00 pm to provide Cultural Diversity Training.

environment.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

Closure of the Probation Adult and Juvenile offices on October 8, 2018, Columbus Day and court holiday, will allow all staff to come together in one day to receive cultural diversity training without disruption. Benefits of an all-staff training include: team building; a sense of closeness amongst co-workers which can improve happiness and productivity in the workplace; acquiring of new skills in a group setting with the goal of contributing to productivity and increasing morale, and human relations and communication (sharing of ideas and experience).

Probation usually conducts an all-day training day on a Court holiday as to not impact work coming from the Superior Court. This year the training will only be a half-day.

Probation Officers will notify their clients of the anticipated closure date, and signs of an office closure will be posted in advance at the Juvenile and Adult office locations.
