SUBJECT: Professional Services Agreement with Coast Landscape Management, Inc.

RECOMMENDATION

Director of Public Works requests approval of and authorization for the Chairman to sign an agreement with Coast Landscape Management, Inc. for the term July 1, 2014 through June 30, 2015 for a three year maximum of \$15,000 per fiscal year to provide landscaping services to the medians of roadways located in County Service Area No. 3.

EXECUTIVE SUMMARY

Approval of the requested agreement will provide continued landscaping services to the medians of roadways located in County Service Area No. 3. The contractor is a local vendor.

Discretionary Justification: To provide landscaping services and to maintain the medians in Airport

Boulevard, Devlin Road and Gateway Road West. This is consistent with the Service Plan for County Service Area No. 3 for 2014-2015 which states that

services may be provided through a contract with an outside vendor.

Future fiscal impact: Sufficient funds have been included in the fiscal year (FY) 2014-2015 County

Service Area #3 budget. The agreement provides for an automatic renewal at the end of the next two fiscal years for a maximum of \$15,000 per fiscal year

under the same terms and conditions.

Consequences if not approved: The County would be unable to provide the required landscaping services

authorized by Resolution No. 2014-67 for County Service Area No. 3.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

County Service Area (CSA) No. 3 was formed by the Napa County Board of Supervisors in 1979 as a mechanism for providing certain extended governmental services to the unincorporated areas surrounding the Napa County Airport. In 1994, the Board added landscaping as one of the extended services that would be provided by CSA No. 3. The cost of landscaping is apportioned to each property within CSA No. 3 in proportion to the special benefit each property receives from the improvements.

Since 2011, Coast Landscape Management, Inc. has provided efficient and reliable service to County Service Area No. 3. This new agreement will ensure that the ongoing landscaping services to the medians of roadways located in County Service Area No. 3 will be performed.
