SUBJECT: Fiscal Year 2014-15 Internal Audit Plan

RECOMMENDATION

Auditor-Controller requests the Board to approve and instruct the Clerk of the Board to file the Internal Audit Plan for fiscal year 2014-15.

EXECUTIVE SUMMARY

In accordance with sections 1111 and 2020 of the *International Standards for the Professional Practice of Internal Auditing* the Auditor-Controller is required to communicate the Internal Audit Plan to the Board of Supervisors and seek approval. The Internal Audit Plan includes a detailed list of audit and other engagements to be performed by the Internal Audit section during fiscal year 2014-15.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

In accordance with sections 1111 and 2020 of the Standards, the Auditor-Controller is required to communicate the Internal Audit Plan to the Board of Supervisors and seek their approval of the plan. Accordingly, the Internal Audit Section is requesting approval of the following plan which would be completed by June 30, 2015:

- Four (4) County-wide Audits
- Three (3) Solid Waste Rate Reviews
- Four (4) Quarterly Engagements for Napa-Vallejo Waste Management Authority
- Three (3) Quarterly Engagements of Cash Receipts for Napa County Housing Authority
- Ten (10) Reviews of Special District and Joint Power Agency Audits
- Four (4) Quarterly Cash Counts of the Treasurer-Tax Collector
- One (1) mandated fee calculations (Booking Fee)
- One (1) Agency/Special Revenue Fund Audit
- Ten (10) Revolving Fund Audits
- Monthly Monitoring of Zone One Lock Box Disbursements

The completion of the above plan is contingent upon additional tasks of higher risk or priority being assigned during the fiscal year as well as maintaining the current staffing level.

Additional Goals

The Auditor-Controller is working towards performing County-wide internal-control and financial procedure audits. These audits will look at overall compliance of policies and procedures to determine if county-wide education or outreach is needed and if the procedure or policy is up to date with current practices. These audits may also result in recommendations of revisions to current procedures and/or policies.

Status of Independence

The Revolving Fund Audits are performed in accordance with generally accepted auditing standards issued by the American Institute of Certified Public Accountants. In accordance with "General Standard No. 2 – In all matters relating to the assignment, an independence in mental attitude is to be maintained by the auditor or auditors.". However, the majority of the audits performed by the Internal Audit Section are performed in accordance with the International Standards for the Professional Practice of Internal Auditing (Standards). In accordance with Standards, specifically attribute standard 1100 – Independence and Objectivity; the internal audit activity must be independent, and internal auditors must be objective in performing their work. This is interpreted by the standard as follows:

Independence is the freedom from conditions that threaten the ability of the internal audit activity to carry out internal audit responsibilities in an unbiased manner. To achieve the degree of independence necessary to effectively carry out the responsibilities of the internal audit activity, the chief audit executive has direct and unrestricted access to senior management and the board. This can be achieved through a dual reporting relationship. Threats to independence must be managed at the individual auditor, engagement, functional, and organizational levels.

Objectivity is an unbiased mental attitude that allows internal auditors to perform engagements in such a manner that they believe in their work product and that no quality compromises are made. Objectivity requires that internal auditors do not subordinate their judgment on audit matters to others. Threats to objectivity must be managed at the individual auditor, engagement, functional, and organizational levels.

The Auditor-Controller is considered to be independent in accordance with the Standards with the expection of the
