BACKGROUND AND DISCUSSION

An important tool used to support outreach, engagement and community education regarding Groundwater Sustainability is a Frequently Asked Questions (FAQ) document. The purpose of an FAQ document is to provide stakeholders and the community with easy access to clear, concise answers to common questions and concerns regarding groundwater sustainability planning and sustainable groundwater management in the Napa Valley Subbasin.

FAQs are being compiled from questions received by GSA staff, the Groundwater Sustainability Plan Advisory Committee (GSPAC), as well as a review of FAQs prepared by other GSAs in California characterized by similar conditions and concerns as the Napa Valley Subbasin.

The GSA staff and the consultant team will use their resources, expertise and professional judgment to prepare and organize the FAQs. The FAQs will be a dynamic document. Questions may be combined, added and modified to create an approachable and informative knowledge base. Answers to the FAQs may be improved upon over time as additional groundwater-related data is collected and as the GSP process progresses. Responses will refer, as appropriate, to published, authoritative sources and are meant to be well informed but should not construed to be the unchanging, definitive answer to every single question. Some answers may be updated with new information.

The FAQ document will be web-accessible and posted on the GSA website, included in outreach materials, and shared broadly with stakeholders. A subset of the FAQs, or its entirety, may be translated into Spanish to improve targeted outreach and address Communication and Engagement Plan objectives.

An initial FAQ document has been prepared. A revised FAQ document with answers is anticipated to be posted on the GSA website in December 2020.

GSPAC members are welcome to send candidate questions for inclusion in the FAQ document to Jeff Sharp, Supervising Planner, jeff.sharp@countyofnapa.org. Questions should be those that GSPAC members believe are of broad community interest and/or ones that GSPAC members have frequently heard in their interactions with stakeholders.
