SUBJECT: Trump Administration Reviewing National Monuments.

RECOMMENDATION

Napa County's federal advocates will lead a discussion of President Trump's April 26, 2017, Executive Order instructing Interior Secretary Ryan Zinke to review any national monument created since January 1, 1996, that spans at least 100,000 acres. Included on the review list is the 330,780-acre Snow Mountain Berryessa National Monument, that includes part of Napa County.

EXECUTIVE SUMMARY

President Trump signed an executive order on April 26, 2017, instructing Interior Secretary Ryan Zinke to review any national monument created since January 1, 1996, that spans at least 100,000 acres. President Obama, by proclamation, created the 330,780-acre Snow Mountain Berryessa National Monument, that includes part of Napa County, on July 10, 2015. This National Monument is on the list to be reviewed and possible have its protected status revoked.

President Trump is seeking a re-examination of the 1906 Antiquities Act law presidents have used to take unilateral action to protect cultural, historic or natural resources on federal land that is under threat. President Obama used the Antiquities Act to create the Berryessa Snow Mountain National Monument.
