RECOMMENDATION

Authorize the Purchasing Agent to execute a task order with Psomas Company to provide construction management and inspection services for the 2021 Treatment Plant Improvements Project (CIP 20708) in the amount of \$127,100.

EXECUTIVE SUMMARY

Psomas Company will provide third party construction management and inspection services during construction of the 2021 Treatment Plant Improvements Project. The scope of work includes providing full time staffing to monitor the contractor's work for compliance with the contract documents, quality assurance, and safety. The consultant's work also includes coordinating work, conducting project meetings, maintaining project record drawings, preparing daily inspection reports, and reviewing monthly progress payments.

separate project.

qualified firm to provide construction management and inspection services for the project due to their qualifications and simultaneous management of the Pond Levee Maintenance Project (CIP 20707).

BACKGROUND AND DISCUSSION

Psomas Company was selected as the most qualified firm for the project. Third-party construction management offers independent review of project issues and evaluation of solutions that best benefit the project. Psomas will be providing construction management services for the 2021 Collection System Rehabilitation Project and construction management and inspection services for the Pond Levee Maintenance Project as well, which will overlap in construction schedule resulting in decreased costs and increased efficiency for NapaSan. The Psomas CM team also performed B/C review on the project prior to bidding.
