SUBJECT: Award Task Order to Prepare a Wastewater Treatment Plant Master Plan (CIP 20706)

RECOMMENDATION

Authorize the Purchasing Agent to execute Task Order 9 with Hazen and Sawyer to prepare a Wastewater Treatment Plant Master Plan (CIP 20706) in the amount of \$1,513,605.

EXECUTIVE SUMMARY

NapaSan last completed a wastewater treatment plant master plan in 2011. The 2011 master plan successfully defined many projects that NapaSan implemented during the following years; however, master plans are typically only valid for 5-10 years due to changing factors such as flow and loading projections, available technologies, regulatory requirements, and infrastructure improvements that are necessary to maintain an adequate level of service.

Staff anticipates that environmental and community-related changes experienced throughout the last decade such as drought, water conservation, and modified development projections could modify the scope and timing of capacity improvements that were originally recommended by the 2011 master plan. Hazen and Sawyer has been selected to prepare a new wastewater treatment plant master plan that will re-evaluate NapaSan's needs based on new information and will provide updated recommendations for the new planning horizon. The primary goals of the master plan are as follows:

- Facility Condition Assessment
- Provide updated flow and loading projections; evaluate trigger points for capacity upgrades
- Create a 10-Year CIP based on the condition assessment results and the need for capacity upgrades

Additional analysis will include:

- Renewable Energy Production and Energy Management
- Nutrient Management
- Biosolids Management
- Operational Vulnerabilities
- Recycled Water and Potable Reuse
- Capacity Analysis
- Evaluation of Alternatives
- Contaminants of Emerging Concern (CECs)

BACKGROUND AND DISCUSSION

On March 12, 2020, NapaSan sent a formal Request For Proposals to 14 consultants, including local engineering firms. Staff received proposals from three teams and interviewed all three teams during the week of June 1, 2020. Hazen and Sawyer (with Carollo as a subconsultant) was selected as the most qualified team.
