DISCUSSION AND POSSIBLE ACTION: Staff to present report and recommendations on the current Ad Hoc Committee assignments.

EXECUTIVE SUMMARY

One Ad Hoc Committee was disbanded per Board action on August 3, 2009 and one Ad Hoc Committee was added. The following is a summary of the Committees and their respective tasks:

Ad Hoc #1

This advisory committee was established in February 2007 to provide input to the Board and Manager on issues pertaining to the disposition of Oat Hill Quarry, the City of American Canyon's Oat Hill Master Plan, and funding DRTS C&D Phase 2 construction.

Ad Hoc #2

This advisory committee was formed in October 2008 to review the current and potential future management structure of the Authority and to review DRTS operations and make recommendations on resolving any contractual issues.

Ad Hoc #3a

This Committee was formed in August 2009 and three tasks were reassigned from the Ad Hoc #2 Committee per Board approval on August 3, 2009 as follows:.

1. Review of a potential alternative site for disposal of a portion of municipal solid waste.
2. Develop special material rates
3. Review of conversion technology proposals
