RECRUITMENT

DISCUSSION AND POSSIBLE ACTION: Authorization to enter into an agreement with CPS Human Resource Services for the recruitment of an Executive Director for the Authority at an estimated cost of \$20,000.

EXECUTIVE SUMMARY

The Ad Hoc #2 advisory committee was formed in October 2008 to review the current and potential future management structure of the Authority. Based on prior discussions, a draft Executive Director job description was provided to the Committee on September 30, 2009 for discussion and direction. Revisions to the draft description have been made based on those discussions. Additionally CPS Human Resource Services, with whom Napa County currently contracts for executive recruitment services, was contacted for a proposal. Items B and C of the attached proposal would be the basis of the agreement with CPS at an estimated cost of \$13,500 plus reimburseable expenses estimated at \$6,500, for a total estimated cost of \$20,000.

BACKGROUND AND DISCUSSION

The Ad Hoc #2 advisory committee was formed in October 2008 to review the current and potential future management structure of the Authority. Based on prior discussions with the Committee, a draft Executive Director job description was provided to the Ad Hoc on September 30, 2009 for discussion and direction. The Committee recommended several changes to the draft description and in addition recommended using a professional recruitment search firm to conduct the recruitment. The revised description is attached for information only as the recruiting firm may wish to further edit for review prior to initiating recruitment.

CPS Human Resources Services, with whom Napa County currently contracts for executive recruitment services, was contacted for a proposal; that proposal is attached for reference. The Authority Manager is recommending Items B and C of the attached proposal as the basis of the agreement with CPS at an estimated cost of \$13,500 plus reimburseable expenses estimated at \$6,500, for a total estimated cost of \$20,000.
