RECOMMENDATION

HDR AGREEMENT

REQUESTED ACTION: Approval and authorization for the Chair to sign Agreement No. 09-03 with HDR Engineering, Inc., in an amount not to exceed \$23,477 for the term February 6, 2009 through June 30, 2009, with a provision to extend for one additional year at no additional cost, to review the Devlin Road Transfer Station (DRTS) operations contract and to provide recommendations related to the definition of special materials.

EXECUTIVE SUMMARY

HDR Engineering, Inc., will review the Devlin Road Transfer Station (DRTS) operations contract with staff from Northern, DRTS and the Authority as well as reviewing the definition of special material rates at a cost not to exceed, \$23,477.

BACKGROUND AND DISCUSSION

HDR Engineering, Inc., was instrumental in developing the Agreement between the Authority and Northern, the current Devlin Road Transfer Station (DRTS) operator. A review of DRTS operations and the Agreement is in order after approximately eighteen months of operations to make certain both the Authority and Northern are in compliance with the provisions of the Agreement. It is anticipated that this review will be completed by the end of the current fiscal year, however, a provision to extend the agreement for one additional year is provided with no increase to the total cost of \$23,477.
