RECOMMENDATION

STANDBY GENERATOR PROJECT

REQUESTED ACTION: Approval and authorization for the Chair to sign the following related to ACSL Standby Generator Project:

- 1. Agreement 2019-03 with Aptim Environmental and Infrastructure LLC (APTIM) in the amount of \$14,260, effective February 7, 2019 to June 30, 2019, with extension provisions, for engineering design, construction management, and permitting services; and
- Budget Adjustment No. NVW001 establishing a \$25,000 Professional Services Appropriation in Program 19810 with offsetting revenue from a reduction in Infrastructure Appropriations in the DRTS Phase 3 Program 17810.

EXECUTIVE SUMMARY

The Bay Area Air Quality Management District (BAAQMD) has recently issued a clarification concerning the number of annually permitted hours the flare system at the American Canyon Sanitary Landfill (ACSL) can be off line. The permit allows up to 240 hours per year of non-operation for maintenance purposes. The previous practice at landfills in the Bay Area has been to include downtime due to power outages in that 240 hour allowance. BAAQMD has ruled that the 240 hour allowance is only for scheduled maintenance, which now makes power outages a reportable violation of permits.

In order to minimize future permit violations due to this ruling, staff is recommending installation of a standby generator system to automatically provide backup power during PG&E outages. The recommended contract with Aptim would provide design and construction management services for the project. It is anticipated that

construction could begin in late spring or early summer and the system could be fully operational before the end of the year.
