All issues are abated as they arise. The March monthly report is attached.

Leachate

Leachate is being re-circulated on a pilot program to the newer southern section of the landfill. It appears the leachate mound is starting to reduce due to the increased cones of depression around the wells. 307,200 gallons were transported for disposal. See the attached quarterly testing results summary letter and report.

Storm Water Monitoring

Staff is continuing the winter monitoring program. Areas of concern have been abated.

Inspection Reports

The Local Enforcement Agency inspection report for the quarter is attached.

DEVLIN ROAD TRANSFER STATION**Tonnage**

The Authority accepted 58,461 tons at the Transfer Station during the quarter. This represents a increase of 1,135 tons or 2% more than the same quarter in the prior fiscal year. See the attached tonnage information sheet. In addition, 556 tons was hauled to Keller Canyon from the City of Vallejo's Lemon Street Facility.

Inspection Reports

The inspection reports are attached. The 5-year permit review was approved by the Local Enforcement Agency.

Recycling and Reuse Area

The area was striped to better mark traffic flow and parking. Phone and electricity are in, so the computer works.

Construction and Demolition

The equipment is installed, but the operator is still adjusting the operations to improve the implementation.
