BACKGROUND AND DISCUSSION**AMERICAN CANYON SANITARY LANDFILL**Air Quality

All issues are abated as they arise. The July monthly report is attached.

Leachate

Leachate is being re-circulated on a pilot program to the newer southern section of the landfill. It appears the leachate mound is starting to reduce due to the increased cones of depression around the wells. 264,000 gallons were transported for disposal. An additional 672,037 gallons were used in the shallow soaker well system.

Storm Water Monitoring

DEVLIN ROAD TRANSFER STATIONTonnage

The Authority accepted 66,267 tons at the Transfer Station during the quarter. In addition, 250 tons was hauled to Keller Canyon from the City of Vallejo's Lemon Street Facility.

The inspection reports are attached. Recycling and Reuse Area Improvements were made to the area to clarify the flow through the site.

Construction and Demolition

Separate collection initiated in the middle of March and a total of 606 tons was accepted. The contamination rate was around 30%. Allied Waste continues to make improvements to the program.
