LETTER OF AGREEMENT:

REQUESTED ACTION: Approval and authorization for the Executive Director to enter into a Letter of Agreement with the City of Napa for reimbursement to the Authority of costs associated with the Sharps Collection event on September 29, 2012.

EXECUTIVE SUMMARY

The City of Napa is planning to host a free public sharps collection event on September 29. Last year, the Authority agreed, informally, to an arrangement allowing the City to use the Authority's current Household Hazardous Waste agreement with PSC to provide equipment and disposal for the event. The mechanism to accomplish this was for the Authority to pay PSC directly for the services they provided during the sharps event and be reimbursed by the City. The cost of last year's event was under \$3,000.

This year, the Auditor/Controller has raised legal and procedural questions about continuing this informal past practice. In order to resolve these issues for the September 29 event, and potential similar future events, staff is proposing a letter agreement between the Authority and City that would provide the formal basis for continuing this past practice.
