### **EXECUTIVE SUMMARY**

Commission members currently serve on three standing committees and two special ad hoc committees. Appointments to the standing committees are made by the Board of Supervisors based on recommendation from the Commission. The two current ad hoc committees were established by the Commission. Term expiration dates vary depending on the particular committee appointment. Presently, three committee appointment terms are set to expire December 31, 2012 and staff requests the Commission reappoint current members or appoint new members to serve on the committees listed below. Commission action to appoint members to the standing committee will be forwarded as a recommendation to the Board of Supervisors. It should be noted that this item was continued from the December 5, 2012 Commission meeting pending full Commission attendance and discussion.

The openings are as follows:

<u>Watershed Information Center and Conservancy of Napa County (WICC):</u> Commissioner Basayne - term expires December 31, 2012. Appointment made by the Board.

Napa County Airport Advisory Commission: Commissioner Pope - term expires December 31, 2012. Appointment

made by the Board.

<u>Napa Pipe Design Standards Ad Hoc:</u> Commissioners Scott and Fiddaman - term expires December 31, 2012. Appointment made by the Commission.

<u>Climate Action Plan Ad Hoc:</u> Commissioners Pope and Phillips - term expires December 31, 2012. Appointment made by the Commission.

Committees where no terms are set to expire are: Wildlife Information Center and Conservancy

## **Proposed Actions:**

- Appoint two members to an ad hoc subcommittee related to the draft development standards and design guidelines for Napa Pipe;
- 2. Appoint two members to an ad hoc subcommittee related to development of a Climate Action Plan for the unincorporated Napa County;
- 3. Recommend one member to the Board of Supervisors for appointment to the Watershed Information and Conservancy Center (WICC) and
- 4. Recommend one member to the Board of Supervisors for appointment to the Airport Advisory Commission.
