BACKGROUND AND DISCUSSION

This item will consist of a brief presentation by commercial real estate broker Bill Kampton and staff concerning market trends and current business conditions for the industrial and business park areas of Southern Napa County. Mr. Kampton has over 30 years experience as a commercial real estate broker in the North Bay Area specializing in Napa's commercial real estate market, and is a long time resident of Napa. Attached is his firm's latest market summary for Napa and nearby communities. In 2011 and 2012, Mr. Kampton served as a member of the County's Airport Industrial Area Blue Ribbon Committee, which was tasked by the Board of Supervisors to identify ways of enhancing development opportunities, to seek out opportunities to create jobs, and to explore measures to overcome obstacles to business park development. Mr. Kampton last presented to the Commission in October 2013 and June 2017, and to the Airport Land Use Commission in February 2016.
