Request: Annual appointments and reappointments of Commission members to Ad Hoc and Standing Committees.

EXECUTIVE SUMMARY

Commission members currently serve on three standing committees and two special ad hoc committees. Annual appointments to the standing committees are made by the Board of Supervisors based on recommendation from the Commission. The two current Ad Hoc committees were established by the Commission. Term expiration dates vary depending on the particular committee appointment. In addition, the Commission at their January 16, 2013 voted to appoint a Commission member to serve as a liaison to the Napa County Local Food Advisory Council.

Presently, five committee appointment terms for four separate committees are set to expire December 31, 2014 and staff requests the Commission reappoint current members or appoint new members to serve on the committees listed below. Commission action to appoint members to the standing committee will be forwarded as a recommendation to the Board of Supervisors.

The openings for Standing Committees are as follows:

Watershed Information Center and Conservancy of Napa County (WICC): Commissioner Pope - term expires

December 31, 2014. Appointment made by the Board of Supervisors. The WICC Board meets every other month on the fourth Thursday 4:00-6:00 PM in the 2nd floor conference room of the Hall of Justice Building, 1125 Third Street, Napa, Ca. (New location to be determined due to the South Napa Earthquake.)

<u>Napa County Airport Advisory Commission:</u> Commissioner Basayne - term expires December 31, 2014. Appointment made by the Board of Supervisors. The AAC Meetings are held the first Monday of the month at noon at the Napa County Airport, 2030 Airport Road, Napa.

<u>Wildlife Conservation Commission:</u> Commissioner Phillips - term expires December 31, 2014. Appointment made by the Board of Supervisors. Commission meetings are held quarterly on Mondays 4:00-6:00 PM in the 2nd floor conference room of the Hall of Justice Building, 1125 Third Street, Napa, Ca. (New location to be determined due to the South Napa Earthquake.)

The openings for Ad Hoc Committees are as follows:

<u>Napa Pipe Design Standards Ad Hoc:</u> Commissioners Scott and Fiddaman. Appointment made by the Commission. Meetings are held on an as needed basis. This subcommittee will be disbanded due to project completion.

<u>Climate Action Plan Ad Hoc:</u> Commissioners Pope and Basayne - term expires December 31, 2014. Appointment made by the Commission. Meetings are held on an as needed basis.

Commission Liaison appointments are as follows:

<u>Napa County Local Food Advisory Council:</u> Commissioner Phillips. No expiration terms. Special meetings are held every other month at various locations.

Proposed Actions:

- 1. Recommend one member to the Board of Supervisors for appointment to the Watershed Information and Conservancy Center (WICC);
- 2. Recommend one member to the Board of Supervisors for appointment to the Airport Advisory Commission;
- 3. Recommend one member to the Board of Supervisors for appointment to the Wildlife Conservation Commission
- 4. Appoint two members to an ad hoc subcommittee related to development of a Climate Action Plan for the unincorporated Napa County.
