Request: Annual appointments and reappointments of Commission members to Standing Committees.

EXECUTIVE SUMMARY

Commission members currently serve on three standing committees. Annual appointments to the standing committees are made by the Board of Supervisors based on recommendation from the Commission. Term expiration dates vary depending on the particular committee appointment. In addition, at their January 16, 2013 the Commission voted to appoint a Commission member to serve as a liaison to the Napa County Local Food Advisory Council.

Presently, no committee appointment terms expire December 31, 2019. However, staff requests the Commission either confirm existing current members or appoint new members to serve on the committees listed below. Commission action and/or changes to appointed members to the standing committees will be forwarded as a recommendation to the Board of Supervisors.

The openings for Standing Committees are as follows:

<u>Watershed Information and Conservation Council of Napa County (WICC)</u>: Commissioner Cottrell - term expires December 31, 2022. No action is needed at this time unless Commissioner Cottrell does not want to continue this appointment. Staff is only recommending confirmation of continued appointment. Appointment made by the Board

of Supervisors. The WICC meets every other month on the fourth Thursday 3:00-5:00 PM at 625 Burnell Street, Napa or at various site locations. Next meeting is February 27, 2020.

<u>Napa County Airport Advisory Commission (ACC)</u>: Commissioner Mazotti seat runs until December 2020. No action is needed at this time unless Commissioner Mazotti does not want to continue this appointment. The AAC Meetings are held the first Monday of each month except August, at Noon at the Napa County Airport, 2030 Airport Road, Napa.

<u>Wildlife Conservation Commission</u>: Commissioner Whitmer - term expires December 31, 2020. No action is needed at this time unless Commissioner Whitmer does not want to continue this appointment. Commission meetings are held quarterly on Mondays 3:00-6:00 PM and location is held at the Napa Main Library, 500 Coombs Street, Napa or at various site locations. Next meeting is March 30, 2020.

The opening for the Commission Liaison appointment is as follows:

<u>Napa County Local Food Advisory Council</u>: There are no expiration terms associated with this representation. Commissioner Hansen was appointed in December 2019. Special meetings are held every other month at various locations.

Proposed Actions:

- 1. Confirm existing appointment of Commissioner Cottrell to the Watershed Information and Conservation Council (WICC);
- 2. Confirm existing appointment of Commissioner Mazotti to the Airport Advisory Commission;
- 3. Confirm existing appointment of Commissioner Whitmer to the Wildlife Conservation Commission; and
- 4. Appoint one member to the Napa County Local Food Advisory Council.
