RECOMMENDATION

PUBLIC HEARING: RESTATEMENT AND AMENDMENT TO UVDS FRANCHISE AGREEMENT

DISCUSSION AND POSSIBLE ACTION: Staff recommends Adoption of Resolution 2020-04 and Board approval and authorization for the Chair to sign the Restatement and Amendment to former Agency Agreement #95-09 (Upper Valley Disposal Service) (as amended).

EXECUTIVE SUMMARY

In 2018 the Board directed staff to undertake a review and update of both the UVDS and CFL Franchise agreements. While operationally adequate, the agreements date back to the mid 1990's (as amended several times) and much of the administrative language and process had become dated. Staff engaged in this effort (interrupted for several months by the Covid-19 and fires), and has now completed a revised document. This is considered a "Restated and Amended" agreement, meaning that it will become a new agreement with a 2020 contract number.

The proposed changes are described in more detail in the attached memorandum.
