### RECOMMENDATION

#### **CALIFORNIA INTEGRATED WASTE MANAGEMENT ACT**

**DISCUSSION AND POSSIBLE ACTION:** Staff to provide an update on the status of activities relevant to the Act.

### EXECUTIVE SUMMARY

**Report Reformatting** - Upper Valley Disposal and Recycling Services has produced a draft summary report formatted to show landfilled waste amounts for residential, commercial, and drop boxes from each UVWMA member community - see attachment. UVDRS has agreed to provide quarterly reports in this format and will include number of service accounts for each category and community.

**Results of State Review of UVWMA Annual Report for 2007** - The CA Integrated Waste Management Board has sent notification that it has reviewed the UVWMA 2007 report on the status of local "waste diversion" - see attachment. The CIWMB has calculated a 5.2 (pounds) per person per day disposal rate for the UVWMA area compared to a target disposal rate of 7.5. Local jurisdictions with calculated rates under the target undergo CIWMB compliance review on a four year cycle, instead of the annual cycle used previously. The target disposal rate represents the statewide diversion goal threshold of 50%.

**Home Composting Workshops** - *The 2009 workshop schedule appeared in the UVDS Spring Newsletter.* The next workshop, on worm composting, is scheduled for Saturday, May 30 at 9 a.m. at the Napa Valley Museum in Yountville. The next up-valley workshop on landscape greenwaste composting will be held on Wed., Sept. 23 at Whiting Nursery in St. Helena at 6 p.m.

### **Napa County Solid Waste Local Task Force**

The Local Task Force has completed its state mandated work of reporting on the status of waste management plans and facilities in the county. Group members, including staff representing UVWMA, Napa County, and the cities of Napa and American Canyon meet quarterly to consider cooperative efforts in waste reduction, recycling, composting, household hazardous waste, and waste disposal.
