BACKGROUND AND DISCUSSION

CURRENT ISSUES

Enforcement of Non-Franchisee Drop Boxes

The Company and the LEA have noticed an increasing number of non-franchisee drop boxes in the UVA area. The

LEA cited several offenders. The LEA will be present to provide the Board an update on this issue, which is important in that it directly impacts the financial operations of the company and the Agency.

Update on Extended Producer Responsibility (EPR) Programs and Related Legislation

EPR and "take back" requirements are growing trends to minimize the impact to the local government (and their rate payers) from products that are difficult to dispose of. Sonoma County has recently adopted an EPR Implementation Plan and various legislation, such as AB 1193 (Thermostat Recycling), and AB 501 (Sharps Take Back) is working its way through Sacramento. The Agency Manager will continue to update the Board on trends in this area.

WRAP Award Winners

Two area businesses, Beaulieu Vineyards and Trinchero Family Estates, were recently awarded excellence in waste reduction awards from the CIWMB.

Composting Classes

The last class, held in St. Helena, attracted 47 attendees.
