## **BACKGROUND AND DISCUSSION**

## Rate methodology revisions that are to be completed by July 1

This was discussed previously on the agenda as part of the Request for Proposals.

## Review of the Rate Structure

The rate structure is extensive and confusing for both the public and the franchisee. A simplification of the structure is being developed that would be incorporated in future rate setting processes. This will be coordinated with the rate methodology review.

## Universal Waste Recycling

Effective July 1, CFL will be accepting all electronic waste for no charge. This will be highlighted in the July Newsletter. All electronic waste will be accepted with no limitation. We will evaluate the cost impact, if any, in the near future. If electronic wastes are delivered to the upcoming hazardous waste event, UVDS will accept and stock pile these wastes until their program at CFL starts. We are not encouraging this behavior, because it will confuse the intention of the household hazardous waste event.

We are preparing a grant application to assess universal waste, especially battery, recycling for submittal to the California Integrated Waste Management Board.

#### Franchisee Outreach Expansion

Staff continues to work with the Franchisee to implement and expand on their plan. We received a very nice letter from a teacher in Angwin about the landfill and recycling tour they took. UVDS continues to do a very nice tour. The Agency offers transportation reimbursement to facilitate tours when asked.
