RECOMMENDATION

PUBLIC HEARING: APPROVAL OF THE 2018/2019 FISCAL YEAR BUDGET

REQUESTED ACTION: Staff requests approval and adoption of Agency Resolution No. 18-01 adopting the proposed final budget for fiscal year 2018/2019.

EXECUTIVE SUMMARY

Staff will present the proposed fiscal year 2018/2019 budget for Board approval.

Revenue: Landfill revenue for the current year is estimated at\$750,000. This is a one time event as a result of the October 2017 fires. For next year we expect a return to normal, and as such we have once again budgeted \$170,000 as the economy continues to improve and construction activity remains strong in the Upper Valley. The budget also includes the usual \$25,000 CalRecycle recycling program funds, which seems safe for at least the coming year.

Expenses: Most budgeted expenses are similar to last year's budget, with minor increases to account for cost of living (particularly County staff salaries) and inflation. Administrative expenses have been increased by \$15,000, and due to the success of the Green Business Program, \$5,000 has once again been included for waste audits of both wineries and other businesses in the UVA territory. \$10,000 is included for use of outside consultants, should a need arise (any consultant contract would return to the Board for specific approval).

Fund Balance: The Agency commenced 2010/2011 with a \$35,000 fund balance, the minimum allowed under Board policy. The Agency steadily increased its balance, and started the fiscal year at \$59,359. We are estimated to conclude the year above \$625,000 due to the fire revenue, significantly above the Board minimum.
