### SB 1383 PRESENTATION

DISCUSSION AND POSSIBLE ACTION: Board to receive a presentation by Marshalle Graham, Senior Environmental Scientist with CalRecycle, on SB 1383.

### EXECUTIVE SUMMARY

Marshalle Graham, Senior Environmental Scientist with CalRecycle, will present an overview on SB 1383. SB 1383 was signed into law in September 2016 by Governor Brown. SB 1383 established statewide methane emissions targets in various sectors of California's economy. As it pertains to CalRecycle, SB 1383 establishes targets to achieve a 50 percent reduction in the level of statewide disposal of organic waste from the 2014 level by 2020 and a 75 percent reduction by 2025. Ms. Graham will present SB 1383's requirements, objectives and jurisdiction responsibilities.

### ENVIRONMENTAL IMPACT

As it pertains to CalRecycle, SB 1383 establishes targets to achieve a 50 percent reduction in the level of statewide disposal of organic waste from the 2014 level by 2020 and a 75 percent reduction by 2025. Ms. Graham will present SB 1383's requirements, objectives and jurisdiction responsibilities.

SB 1383 requires the following of local governments:

- Provide organic waste collection to all residents and businesses
- Establish an edible food recovery program that recovers edible food from the waste stream
- Conduct outreach and education to all affected parties, including generators, haulers, facilities, edible food recovery organizations, and city/county departments
- Capacity Planning: Evaluate your jurisdiction's readiness to implement SB 1383
- Procure recycled organic waste products like compost and renewable natural gas (RNG)
- Inspect and enforce compliance with SB 1383
- Maintain accurate and timely records of SB 1383 compliance

The following highlights how SB 1383 differs from AB 939. SB 1383 does not have diversion goals; rather programmatic requirements. SB 1383 does not allow for good faith effort as AB 939 does. SB 1383 has a \$50 per event to \$10,000 per violation per day penalty for non-compliance. SB 1383 requires service for all generators (including residents).
