Karl Ono, Associate Engineer, gave a presentation on the Primary Clarifier and DAF Clarifier Rehabilitation Project. He reported on the background of the project, condition assessment findings, and the rehabilitation priorities. The engineer's estimate for the project is \$1,200,000. Ono reviewed the general scope of the project and the anticipated schedule.

9. **GENERAL MANAGER REPORT:**

a. Director of Administrative Services/CFO, Jeff Tucker reported on the PG&E power outages. NapaSan was without power for 42 hours and operated on generators with no loss in continuity of service. Recycled water was also available during this time. Tucker reported that operations experienced some unexpected
