That: for and in consideration of the sum of Two Thousand Seven Hundred Dollars (\$2,700.00), the receipt and sufficiency of which is hereby acknowledged, the grantors, for themselves, their heirs, successors and assigns, do hereby grant and convey unto the grantee for the benefit of the general public at large, a perpetual easement and right of way for the free and unobstructed passage of aircraft by whomsoever owned or operated through the air space hereinafter described over and across all that certain real property situate, lying and being in the County of Napa, State of california, described as follows:

> Being a portfon of that 33.25 acre tract of land described in deed of record in Book 539, page 378, Official Records, Napa County Records, and more particularly described as follows:

COMMENCING at the northwesterly corner of said 33.25 acre tract of land; thence from said point of commencement north 88° 55^t 45" east along the northerly line of said 33.25 acre tract of land, 970.94 feet to a point on the easterly line of a proposed air easement as shown on a map on file in the office of the County Engineer, ^Napa, California, entitled "Proposed Air Easement for East

Said air space is particularly described as follows:

"Upward from a plane above ground level, said plane at its westerly and being at the same elevation as the eastern terminus of the centerline of the east-west runway of the Napa County Airport, as it exists on this date; said westerly end of the plane being distant 200.00 feet easterly from said eastern terminus and on a line perpendicular to the east-west longitudinal axis of said runway; thence from said westerly end, the plane rising at a uniform rate of one foot vertical rise in elevation for every forty feet of horizonal distance in an easterly direction, parallel to said longitudinal axis of said runway.

The plane is approximately 19 feet above the ground level at the westerly boundary of the hereinbefore described real property of grantor, and approximately 35 feet above the ground level at the easterly boundary of said real property."

2. That the grantors will not erect, maintain or suffer any buildings, structures or objects to be erected, placed or remain on said real property which shall enter, project or extend into said air space.

3. The grantors further grant and convey to the grantee, its agents and employees, a continuing right of entry upon said real property for the purpose of maintaining said air space free and clear from any and all trees, poles, buildings, structures or objects of any kind or nature whatsoever, which may at any time extend into said air space, together with the right to remove any such obstructions or objects.

4. Grantors shall take all necessary precautions in their use of said real property to avoid creating interference with radio communications between said airport and aircraft, causing glare in the eyes of flyers using the airport,

impairing the visibility in the vicinity of the airport, making it difficult to distinguish between airport lights and others, or otherwise endangering the landing, taking off or maneuvering of aircraft.

5. It is further understood and agreed that no warning or obstruction lights shall be required by the County of Napa on any pole, buildings or other structures on said real property which do not extend into said air space.

6. It is hunderstood and agreed that these covenants and agreements shall be binding upon the heirs, administrators, executors and assigns of the grantors; that these covenants and agreements shall run with the land and shall be appurtenant to the said lands of grantee, being the Napa County Airport.
