

MINUTES OF THE FEBRUARY 27, 2017 SPECIAL MEETING OF THE BOARD OF DIRECTORS

CALL TO ORDER 1.

The Upper Valley Waste Management Agency met in Special session on Monday, February 27, 2017 at 1:30 p.m. at the Yountville Town Council Chambers. Vice Chair Mohler called the meeting to order at 1:38 p.m.

2. ROLL CALL

The following members were present: Vice Chair Mohler, Member Koberstein, Member Canning. (Member Pedroza was absent, Member Dillon was excused)

3. PLEDGE OF ALLEGIANCE

Member Koberstein led the Pledge of Allegiance.

5. **CONSENT CALENDAR ITEMS**

Α. **Approval of Minutes**

Staff requested approval of the December 19, 2016 regular meeting minutes.

Vice Chair Mohler moved Consent Item 5A for approval.

6. **ADMINISTRATIVE ITEMS**

Α. Elections

Agency Manager mentioned that Mark Luce has been the Chair of this board for a long time but that Mark is no longer on the Board. The Napa County Board of Supervisors has a rotation policy for Chairs but this agency has no policy and who they select is entirely at the discretion of the board.

Member Canning asked if there are portions of Member Pedroza's district that fall into the UVA area?

Agency Manager replies: No. After redistricting District 3 (Supervisor Dillon) covers the entire UVA area. The JPA agreement only specifies that two members of the Board of Supervisors shall be on the UVA Board but it does not specify who it has to be. Board members all have responsibilities for all districts even though they are elected for by district.

Counsel adds: From the JPA, reads that "One of the County Directors shall be a Supervisor representing County Supervisorial District 2 or 3."

Vice Chair Mohler volunteered to be Chair, mentioned being Vice Chair for about 5 years now. Member Canning supports this endeavor.

Vice Chair Mohler nominated Alfredo Pedroza for new Vice Chair term. Member Canning Seconded.

Approved Administrative item 6A: MM, CC, AP, AP(B), DD(X)

California Integrated Waste Management Act Β.

No action taken. Amanda Griffis summarized report provided with agenda.

Amanda is working with Christy Abreu to set up "robo-calls" of Household Hazardous Waste (HHW) event announcements to approximately 6,000 residential customers, to help get the message out. UVDS will pay for it, approximately \$350.00.

Information regarding highlights of Organics Legislation and Timelines was distributed and is now attached in AgendaNet.

C. Strategic Planning/Upcoming Rate Package

The agenda item provided a preview for the board of certain things that might be included in the upcoming rate

package. The Board was generally supportive of proposals One (fixing the cost of extra residential recycling and green waste can at \$20); Two (adding "drive in" rates for residential recycling and green waste); and Four (continuing normalizing rates for non-distance related items (such as opening a gate) across all the jurisdictions. The Board did not support item Three (trying to adjust rates to discourage the carts instead of bins).
