Are you complying with California's recycling and composting laws? Find out here!

Who Must Participate

Recycling is already mandatory for businesses that generate four or more yards of trash per week and all multifamily dwellings with five or more units (per AB 341).

Mandatory Commercial Organics Recycling (AB 1826) requires businesses that generate organic materials to separate the material for composting. Organic materials include food scraps, green waste, landscape and pruning waste and clean wood waste. Businesses that generate specified amounts of organic materials or trash should arrange for composting services, in accordance with the following schedule:

Business Deadlines	Volume Requirements for Participation
April 1, 2016	8 yds. or more of organic waste/wk.
January 1, 2017	4 yds. or more of organic waste/wk.
January 1, 2019	4 yds. or more of solid waste/wk.
January 1, 2020	2 yds. or more of solid waste/wk.

- Complete the application (all categories should be at 80-90% completion)
- Participate in a final walk-through and receive your Green Business Certification

Tips for a Successful Food Composting Program

- Provide convenient, clearly labeled containers in areas where food waste is generated.
- Use containers sized appropriately for employee lifting. Food scraps can be very heavy.
- Always keep the lids closed on the food composting carts to minimize odor and vectors.
- Designate one or more staff members to oversee the program.
- Periodically clean food scrap carts.
