# Commercial Recycling — EASY, Good for Business... and It's the Law!



**YOU'VE HEARD THAT RECYCLING** at your business can save money and is good for the environment, but did you know that it's also required by state law? **AB 341** requires recycling at all commercial sites that generate four cubic yards or more of trash per week and multifamily residential dwellings of five units or more.

**AB 1826** requires businesses that generate organic materials to separate the material for composting. Organic materials include food scraps, green waste, landscape and pruning waste and clean wood waste. Businesses that generate specified amounts of organic materials or trash should arrange for composting services. The requirements phase in beginning in 2016 and continue through 2020.

## OPTIONS FOR RECYCLING

### **RECYCLING COLLECTION SERVICES**

Upper Valley Disposal & Recycling offers these services:

- \* Wheeled Carts: single-stream recycling, greenwaste, or foodwaste
- \* Large Containers: 2, 4, & 6 cubic-yard containers for single stream recycling, cardboard only, glass only, or greenwaste
- Debris Boxes: 10, 20, 30, & 40 cubic-yard boxes for mixed construction waste, clean dirt, concrete/asphalt, cardboard only, or greenwaste





#### **SELF-HAUL TO CLOVER FLAT LANDFILL**

- \* Large Loads Recycling: mixed materials (full charges)
- \* Segregated Loads Recycling: clean dirt, concrete/asphalt, cardboard only, or greenwaste (*reduced charges*)
- \* Bulky Items Recycling: appliances, tires, mattresses, water heaters (charges vary)
- \* Drop-off Separated Household Recyclables: newspaper/magazines, paper, cardboard, glass containers, aluminum cans, tin cans (free)
- \* Electronic Waste: computers, microwaves, printers, TVs (free)
- \* Recyclable Hazardous Waste: see list on next page (free)

## OPTIONS FOR HAZARDOUS WASTE



HAZARDOUS WASTES such as fluorescent lamps/tubes, automotive fluids, pesticides and fertilizers, paint products, cleaners, batteries, etc. cannot be placed in the trash or recycling and are not accepted at Clover Flat Landfill.

### BUSINESSES THAT GENERATE less than 220 lbs. or 27

gallons of hazardous waste per month can dispose of their waste at the **Hazardous Waste Facility**, located at 889A Devlin Road, American Canyon. Appointments are required and there is a fee for this service. For appointments and information: **1-800-984-9661**.

#### UPPER VALLEY WASTE MANAGEMENT AGENCY

sponsors twice yearly hazardous waste collection events. Typically events are held in April in St. Helena and in October in Calistoga. Businesses are charged a fee for this disposal service and appointments are required. To request information on these events email upvalleyrecycles@countyofnapa.org or call 259-8330.
