An act to amend Section 1034 of the Military and Veterans Code, relating to veterans' homes, and making an appropriation therefor.

LEGISLATIVE COUNSEL'S DIGEST

AB 2737, as introduced, Aguiar-Curry. Veterans' homes: Yountville.

Existing law establishes the Veterans' Home of California system, comprised of subsidiary home locations including the Veterans' Home of California, Yountville, in Napa County. Existing law requires all moneys received by a home, or by an officer of a home, to be paid to the administrator of the home, as specified. Existing law requires the administrator, on the 10th day of each month, to forward to the Treasurer all moneys in his or her possession for deposit in the General Fund, as specified.

This bill would require the administrator of the Veterans' Home of California, Yountville, to deposit all revenue generated from employee housing on the campus into a continuously appropriated fund maintained by the administrator for expenditure by the administrator for the maintenance, rehabilitation, and restoration of the Yountville campus. By authorizing the expenditure of these funds, this bill would make an appropriation.

*The people of the State of California do enact as follows:*

1 SECTION 1. Section 1034 of the Military and Veterans Code  
2 is amended to read:

3 1034. (a) Except money received from this state for  
4 disbursement, all moneys received by a home, or by an officer of  
5 a home, including pension and other moneys belonging to members  
6 and other trust moneys, shall be immediately paid to the  
7 administrator of the home. On or before the tenth day of each  
8 month the administrator of each home shall forward to the State  
9 Treasurer all moneys in his or her possession, except pension and  
10 other moneys belonging to members, trust moneys, donations made  
11 to each home, and the emergency fund, hereinafter mentioned,  
12 together with a statement of the sources from which the moneys  
13 have been received. The moneys shall be deposited by the State  
14 Treasurer to the credit of the General Fund; provided, however,  
15 that abatements of support expenditures shall be credited to the  
16 support appropriation current at the time of collection.

17 (b) *Notwithstanding subdivision (a), all revenue generated from*  
18 *employee housing on the campus of the Veterans' Home of*  
19 *California, Yountville, shall be deposited in a fund maintained by*  
20 *the administrator of the home and, notwithstanding Section 13340*  
21 *of the Government Code, is hereby continuously appropriated for*  
22 *expenditure by the administrator for the maintenance,*  
23 *rehabilitation, and restoration of the Yountville campus.*
